NOTICE OF ELECTION ON SCHOOL DISTRICT INCOME TAX

Notice is hereby given that pursuant to resolutions of the Board of Education of Green Local School District, County of Wayne, Ohio, adopted on December 11, 2017, and January 8, 2018, respectively, there will be submitted to the electors of that School District at the election to be held in the School District at the regular places of voting therein, on Tuesday, May 8, 2018, the question of imposing an additional annual school district income tax on the taxable income of individuals as defined in Section 5748.01(E)(1)(b) of the Revised Code (to be described on the ballot as on the earned income of individuals residing in the School District), for the purpose of current expenses, at the rate of three quarters of one percent (0.75%). If a majority of the voters voting on this question vote in favor of it, that income tax will take effect January 1, 2019, and run for a continuing period of time.
